SPECIAL CONDITIONS FOR WEDDING USE PERMIT AT GRAND HAVEN STATE PARK

- 1. ALL VEHICLES ENTERING THE PARK MUST DISPLAY A RECREATION PASSPORT THIS INCLUDES LIMOS AND BUSES.
2. ALCOHOL IS PROHIBITED IN THE ENTIRE PARK.
3. ANIMALS ARE PROHIBITED ON THE BEACH AREA AND MUST BE LEASHED IN ALL OTHER AREAS OF THE PARK.
4. MUSIC BEING PLAYED FOR THE EVENT, MUST BE KEPT AT A LEVEL THAT WILL NOT DISTURB OTHER VISITORS AND MUST NOT CONTAIN OFFENSIVE LANGUAGE.
5. AT NO TIME WILL ANY PARKING SPACES IN THE REGULAR DAY USE LOTS BE RESERVED AHEAD OF TIME FOR THE WEDDING PARTY OR GUESTS.
6. BECAUSE YOU ARE RESPONSIBLE FOR ALL GUESTS INVOLVED WITH YOUR WEDDING, YOU WILL BE RESPONSIBLE TO WARN YOUR GUESTS THAT ALCOHOL IS PROHIBITED IN THE ENTIRE PARK.
7. ANY POWER CORDS THAT ARE USED FOR EQUIPMENT MUST BE BURIED TO A MINIMUM OF 12 INCHES BELOW THE SANDS SURFACE TO PREVENT A TRIPPING HAZARD.
8. TRASH BARRELS AND A DUMPSTER ARE LOCATED IN THE PARK FOR YOUR EVENT.
